I further agree that if any damages shall be occasioned or loss occur, by fire or other, to the horses/ponies, that I will make no claim therefore, and further agree to hold the Windsong Stable Show, owners of the grounds, officials, members or employees harmless from any claim or demand of what so ever kind of nature, that may be occasioned by the horse(s), and to repay to this show on demand, all damages it may sustain by reason of any claim or demand as aforesaid.
